(Amateur Sporting Association) Kiteclub Malcesine del Garda from any and all liability regarding damages to third parties or to him/her self arising out of his/her participation in Kiteboarding activities or frequenting the association, inasmuch as these activities are carried out in complete autonomy and with no provision for assistance during departure from or arrival in the area designated for such purposes or during kiteboarding activity. Furthermore he/she agrees that the above statement of release applies also to the members of the board of A.S.D. (Amateur Sporting Association) Kiteclub Malcesine del Garda, inasmuch as they are individuals subject to separate jurisdiction and, therefore separate liability.

It must be underlined that subscribing to become a member of the aforementioned Association allows the member to undertake kiteboarding only within the designated and in accordance with the A.S.D. Kiteclub Malcesine del Garda regulations, with decree no. 130/45.02 of 17/08/2010 and with subsequent, modifications in decree no. 27/62.01.02 of 28/02/2012.

Failure to adhere to the aforesaid will result in immediate expulsion from the Association with no right of appeal.

RELEASE FORM

Whereas

1. The applicant has requested to become a member of Amateur Sporting Association (A..S.D.) Kiteclub Malesine del Garda, with registered offices at no. 136 Via Navene Vecchia, Malcesine;
2. Amateur Sporting Association (A..S.D.) Kiteclub Malesine del Garda has informed the applicant of his/her obligation, in accordance with Association regulations, to produce a recent medical certificate as demonstration of his/her physical fitness and has also advised the applicant of the advantages of a undergoing a specific medical check-up before engaging in kiteboarding activity and the risks involved should he/she omit to ascertain, his/her good state of health;
3. The applicant asks to be accepted as a member of Amateur Sporting Association (A..S.D.) Kiteclub Malesine del Garda and to be allowed to practise kiteboarding in the area allocated in concession to the above association by the competent authorities, from the date of the present declaration. Furthermore the applicant undertakes to present the above-mentioned medical certificate by

In consideration of the aforementioned, the applicant being duly informed of his/her obligation to present a medical certificate at the moment of application, and, in any case, by the date of start of validity of membership, and in full possession of his general faculties and under his own responsibility.

1. Declares, in the full knowledge and understanding of the potential risks associated with kiteboarding should he/she fail to ascertain in advance his/her own good state of health, his/her desire to become a member of the Amateur Sporting Association (A.S.D.) Kiteclub Malesine del Garda and to be authorised to carry out kiteboarding activity at the Association, from the the date of this declaration, even in the failure to exhibit a medical certificate;
2. Declares that he/she releases the Amateur Sporting Association (A.S.D.) Kiteclub Malcesine del Garda from all and any liability in his/her regard or in the regard of third-parties involved, for damages to self or possessions caused while he/she is found on association premises or undertaking kiteboarding activity and arising from his/her state of health;
3. Undertakes to present to the Amateur Sporting Association (A.S.D.) Kiteclub Malcesine, by his/her next visit to the association, the above-mentioned medical certificate as demonstration of his / her physical fitness and idoneity to practise recreational and sporting activity.
4. Hereby takes note of and acknowledges that this release form refers to all and any activity, sporting or non, carried out by the applicant within the area managed by the Amateur Sporting Association (A.S.D.) Kiteclub Malcesine del Garda, including those activities which, by nature, are potentially dangerous (e.g. Kiteboarding);
5. Hereby acknowledges that this waiver of liability applies also to the members who make up the management committee of Amateur Sporting Association (A.S.D.) Kiteclub Malcesine del Garda, being individuals subject to separate jurisdiction and, therefore, separate liability.

Pursuant to and in accordance with Articles 1341 and 1342, the applicant declares to have specifically read, and to understand and accept the paragraphs 2, (indemnity), 4, (dangerous activity) and 5, (indemnity management committee A.S.D. Kiteclub Malcesine del Garda) of this release declaration.

Information pursuant to Art. 13 of legislative decree no. 196/2003: we hereby inform you that legislative decree no. 196 of 30 June 2003 (on the protection of personal data) applies to the protection of persons and entities with regard to the processing of personal data. Kiteclub Malcesine del Garda (Amateur Sporting Association) and other suppliers or clients of A.S.D. Kiteclub Malcesine del Garda (Amateur Sporting Association). **6)** The Data Controller is: A.S.D. Kiteclub Malcesine del Garda (Amateur Sporting Association). **7)** The members of the board of A.S.D. (Amateur Sporting Association) Kiteclub Malcesine del Garda are responsible for data processing. **8)** According to Article 7 of legislative decree n. 196/2003, reported below in full. The he applicant may exercise his rights with respect to the Data Controller.

1. The interested party has the right to have the confirmation of the existence or otherwise of his personal data, even if unrecorded, and their communication in a comprehensible format. **2.** The interested party has the right to know: a) the origin of the personal data; b) the intended use and method of processing to which the data will be put; c) where new technology means have been adopted, what they are; d) the identification details of the data controller, the managers and the representatives as outlined in Article 5, part 2; e) the subjects and categories of subject to which personal data may be communicated; **3.** The interested party has the right to be informed of / obtain : a) any update, modification or integration of the data with others, where relevant; b) the cancellation, transformation to anonymous data, or blocking of the data if used for illegal purposes; c) a declaration that the operations at (a) and (b) above have been brought to the attention of, also as regards their content, those to whom the data were communicated or diffused by, except in the case where such an operation is impossible our would mean the employment of means disproportionate to the rights protected. **4.** The interested party has the right to appeal, partly or on the whole: a) for legitimate reasons regarding the processing of personal data regarding his/her person, even though pertinent to the scope of collection; b) to the treatment of personal data regarding his/her person for the purposes of the sending of publicity materials or direct sales or market research or commercial communications.
